Chick Sales Get Plucked at the Fair

On March 28, 2000, members of a radical animal rights group called the Animal Rights Foundation of Florida (ARFF) attended a meeting of the Board of County Commissioners. Through their lies, political threats, and other propaganda, ARFF intimidated the County Commissioners into withdrawing funding for the South Florida Fair's planned "Agriplex" expansion.

The ARFF is not the same as PETA and PETA was not officially involved in conning the Commissioners. United Poultry Concerns is another anti-poultry animal rights group, but these people were not responsible either. However, it is very likely that the members of the ARFF that participated in the Commissioner gambit were also PETA members.

In an attempt to ease the concerns of the County Commissioners and get the money needed to build the Agriplex, on August 17, 2000, the Board of Trustees of the South Florida Fair and Palm Beach County Expositions, voted that there would be absolutely no expositions that included genetically engineered plants or animals and no animal sales to the public, with the exception of the Youth Market Hog and Steer Auction, during the annual Fair. This means that our poultry club will not be permitted to sell chicks or ducklings during the fair.

Because the chick and duckling sales make up about 90% of the club's annual income, this did not sit with club members very well. Despite a unanimous objection to the Fair's new animal sales policy, the fair refused to bend. In addition, they also refused to compensate the PBCPFA for the lost income during the fair. Essentially, the fair is demanding that the PBCPFA supply them with thousands of hours of free labor.

Clearly the fair has put the county money ahead of the fair itself and the people who volunteer there. The fair did just fine without the "Agriplex" for nearly a century and can continue doing just fine without the need to hunker down for the animal rights people.

The November PBCPFA meeting will be a major one. We have a lot of decisions to make. Don't forget that this meeting will be on the THIRD FRIDAY of the Month. Since Lee has gotten the fair to allow us to sell chicks on the last day of the fair, there are several issues we need to think about;

A. We can possibly sell chicken handbooks that contain coupons to be redeemed for chicks on the last day. Coupon sales will be recorded in a ledger book and the coupons will expire after the last day of the fair.

B. We have been authorized to have a raffle. Possible items include; Incubator & turner, Chicken Rotisserie, Microwave oven, gift certificates to Higg's, Nest egg, pair of good show birds, etc.

C. Order chicks during the last week to be sold on the last Sunday depending on coupon sales.

D. Egg sales are still permitted all through the fair.

E. Sell Banner Ads for next year.

Any other ideas must be presented and voted on at this next meeting. Any suggestions will be considered.

The Most Notorious Animal Rights Group of the 20th Century

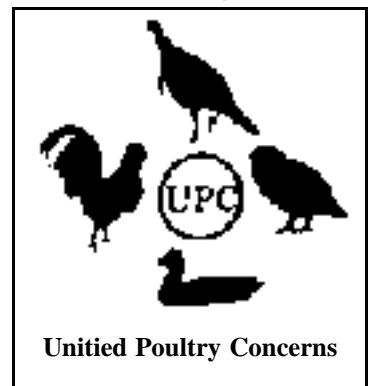
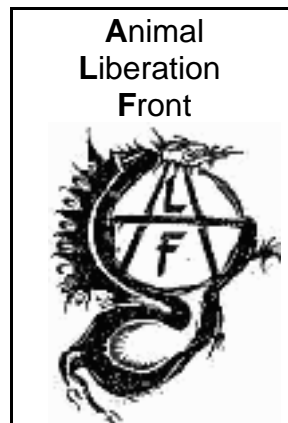

Modern day Animal Rights groups all have strikingly similar views to the Nazis. If you are approached by one of these groups, you now know the kind of people you are dealing with.



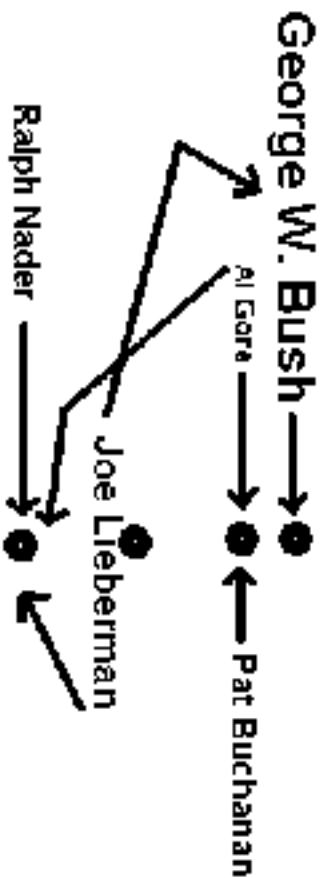

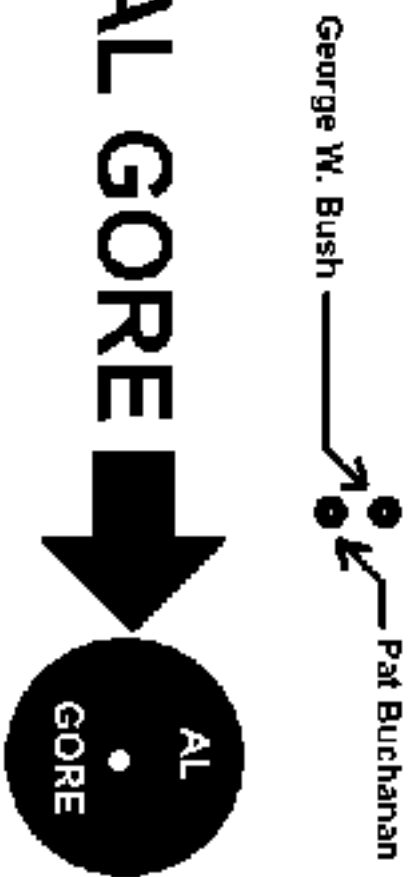
Sample Ballot
